- 1. PROMOTION PERIOD:** The Promotion begins at or about 12:00 PM (noon) Eastern Time ("ET") on March 24, 2025 and ends at 11:59:59 PM ET on June 30, 2025 ("Promotion Period"). The Promotion consists of an instant win game ("Game") and a sweepstakes ("Sweepstakes"), each of which must be entered separately, as described below. The Administrator's computer is the Promotion's official clock.
- 2. The entrant must then complete and submit the registration form with all required information, which may include, but may not be limited to, complete first and last name (no initials), street address (no P.O. Boxes will be allowed), city, state, ZIP Code, phone number, and date of birth. After registering or submitting a valid e-mail address on subsequent days, the entrant must then follow the on-screen instructions to play the instant win game (“Game Play”). After the Game Play, the entrant will receive notification on the Website screen as to whether the entrant is a potential “Instant Winner” (“Notification”). No more than one thousand ten (1,010) Game Prizes will be awarded for any reason.
